IN LIEU OF PAYING THE FINE, you may contest the citation by requesting to appear before the Town of Jupiter Magistrate at the next available Code Compliance hearing. To do so, you must call the Code Compliance Secretary at 561-746-6201 within ten (10) days of issuance of this citation. **HEARING TIME & LOCATION: 10:00AM in Town Council Chambers, 210 Military Trail, Jupiter, FL 33458.** If you fail to either pay the fine or appear at the hearing to contest the citation, you shall be deemed to have waived your right to contest the citation and a judgment may be entered against you for an amount up to the maximum civil penalty. **Any person who willfully refuses to sign and accept a citation issued by a police officer or code enforcement officer shall be guilty of a misdemeanor of the second degree, punishable as provided in Sec. 775.082 F.S. or Sec. 775.083 F.S. (60 days in jail or \$500.00 or both).**
